- Increase chapter visibility in NE Florida by participating in at least one community-based event.
- Provide accurate, clear, and consistent communication that promotes the chapter goals, mission/vision, and brand through the website, email, social media, and face-to-face interactions with members.
- Identify processes for each area, document steps required and maintain documentation in a repository that is accessible to all.

Have you ever wondered how many members are in the Northeast Florida Chapter? Here's the scoop...

Our current numbers for March 2012 are at an impressive 344 members. Of the 344 chapter members, 113 are also members of the ASTD National organization. This equates to 32.8% dual membership.

As of January 1, 2012, ASTD National increased the CORE (Chapter Operating Requirements) joint membership requirement from 30% to 35% for all chapters. CORE refers to a set of performance guidelines established by the ASTD National organization designed to help chapters deliver consistent benefits to members. Our chapter has set a goal to get a head start on achieving this year's CORE membership requirements. We ask you to consider becoming an ASTD National member and take advantage of the benefits the
