To Be or Not to Be...A Corporate Member

If you've ever considered the benefits of corporate membership, but were unsure if you or your organization qualifies, read on.

ASTD-Northeast Florida's corporate membership provides companies and organizations with an opportunity to invest in the professional development of five or more employees at a significant discounted rate. To qualify for corporate membership, all employees must be from the same company or organization. Each group member receives all the benefits of standard membership.

Corporate memberships can be paid in one of two ways. First, the organization can pay or reimburse the membership fees, in which case the company owns all memberships, which are transferable to any employee selected for participation.

Second, memberships can be self-paid by the employee, in which case membership belongs solely to the employee and is not transferable.

Q: I want to register online for the next chapter event. Should I login to the ASTD NEFL website to do so?

A: Yes, there are **two** reasons to always login to ASTD's Northeast Florida's web site (http://astdnefl.org). First, logging in before you register for an event will ensure you are seeing the appropriate registration options and best prices for the events. Second, logging in before you browse the web site will ensure you see more details and information, especially if you are a member.

The login area is on the left side of the web page. To login in to the web site, use your email address (where you receive chapter announcements) as your ID and then type your password. If you do not remember your password, click the "Forgot Password" link to create a password.
